The Board of Education of Danville Community Consolidated School District No # 118 reserves the right to reject or accept any and all proposals and to waive informalities in bidding. The bidder affirms by his/her signature that the bidder does comply with all requirements of Civil Rights and Executive Orders governing nondiscrimination of employment. The competency and responsibility of all bidders will be taken into consideration.

This bid is to become a contract when accepted by the Board of Education, which content will include the invitation to bid and all other bid documents. The contract will be awarded to the lowest bidder whose products meet all specification, terms, and conditions of this bid. Please refer to Page 2 for additional information regarding quality of products, specific brands, requested samples, and submitting complete product information.

The vendor certifies that the vendor is not barred from bidding on this contract as a result of a conviction for either bid-rigging or bid-rotating under Article 33E of the Criminal Code of 1961.

#### **Quality of Service:**

- A delivery schedule, workable for both the dairy company and the school district, will be agreed upon before the start of school. A contract with the successful bidder may be terminated at any time during the school year should there be problems with the delivery schedule other than when caused by emergency situations.
- There shall be no early morning deliveries prior to the school being opened by the custodians.
- Someone must be on hand to accept the product.
- Vendor is responsible for rotating product in all milk coolers at each delivery location.
- The vendor shall be responsible for replacing any damaged, spoiled, or unsanitary product.
- Milk crates **MUST** be clean.
- EMPTY MILK CRATES ARE TO BE PICKED UP IN A TIMELY MANNER, NO LESS THAN ONCE A WEEK.
- If the condition of the product (s) does not meet the acceptance of the Food Service Department, we reserve the right to terminate the contract in portion or in full.
- Any on-going problem with leaking cartons may result in the termination of the purchase contract.
