The competency and responsibility of all bidders will be taken into consideration.

This bid is to become a contract when accepted by the Board of Education, which content will include the invitation to bid and all other bid documents. The contract will be awarded to the lowest bidder whose products meet all specification, terms, and conditions of this bid
