

## PARENT/GUARDIAN PERCEPTION - CELL PHONE SURVEY RESULTS 4/8/2022

## My child / children attend (mark all that apply):



My child should be allowed to bring their cell phone to school. 406 responses





A teacher needs to have control of a class, not trying to tell not 1, not 2 but almost 20 kids during a lesson to get off a phone. My daughter even said, mom I can't learn or stay focused in class so much was going on. Thus why her grades dropped, then she was influenced to make a bad decision.

- For safety purposes I want to be able to reach my children
- Please stop treating my children like they are prisoners. They don't need clear backpacks or locked cell phones. Deal with the discipline issues and leave the good kids alone.
- Adults in the district are not always doing the correct things. The safety of my child is my biggest concern. I have had teachers misuse their authority and wouldn't let my child leave their room to call home.
- I feel like children should be able to have their phone incase the parent texts to let them know something, they don't need to have it out during class but can check them in free time or after school
- It is a distraction for the elementary children and should not have them at school it distracts other children
- The main reason my children have cell phones is for their own safety. Until Danville schools gets the fighting and other various issues under control, my child will be bringing their cell phones to school and will have their phones on them at all times. The ONLY reason my child received a cell phone at 14 was for her own safety at NRMS.
- Cellphones have an option to be changed to do not disturb, and my child always has phone placed on it while at school, so I do not see a use for the school to lock a cellphone in a pouch daily. Rules are already in place as far as cellphone use and those rule can remain and followed.
- I think the kids should be able to have their phones so the parents can leave them a text message or a voicemail, because you can not always get ahold of the office.

- Cellphones shouldn't be allowed at the elementary level. I don't see the necessary need to have one at those grades levels. For middle and high school, I can see a system with phones being locked up, lots of employers currently do this. If there's any emergency parents/guardian and contact the office.
- Perhaps there should be tiered levels of cell phone use and responsibility. Ex: Elementary no phones allowed in classroom, they would have to stay in bookbags silenced or in do not disturb mode. Middle school have them with the student and only allow students to use them during down time but they must be silenced/do not disturb. High school, loosen the restrictions as you would in the workplace. Don't be on your phone during instruction or passing periods but allow them to have it at lunch or study halls, etc.
- Students should be allowed to use them during homeroom. Lunch use should also be allowed if no fights recently. Some students use the kindle app to read books, some check skyward, etc.
- I think the only time they should be allowed to use their phones is during there lunch period and before and after school.
- My child will have access to her phone at all times in the school. We discuss using her phone during school hours. While there may be a district policy about not having cell phones used during school hours, her teachers have allowed it consistently during class time when they are not in a lesson. There seems to be a disconnect between policy and enforcement which is not a student issue. We will not be participating in the Yonder pouches at any time. If there is an emergency in the school, my child will have immediate and unrestricted access to her phone to contact us.
- We live in day & age where having contact with your kid is needed ..With so many unsafe unknowns in this world I ALWAYS wanna be able to get in contact with my child not thru second hand relay talk in case of emergency
- I would not allow my child to put their phone in a pouch that restricts it use. This is an overreach this is overreach by the school system. This isn't the 1950s. Children need communication options. Solve bigger problems like lack of teachers and staff
- We live in a world of technology. Students need to be taught appropriate use of phones and when you can or can't use them. This is life in 2022. Google is their friend. We can try and ignore this or we can move ahead with the times and teach students how to be responsible adults. They will not go off to a job or college without a cell phone in hand. They should be stored off and out of sight during class time except when allowed by teachers to have out. They should be allowed to have them out during passing periods, before/after school and during lunch. This should be their free time and an appropriate time to use it. (As I assume most staff use during their lunch breaks, passing periods, plan time when they do not have other assigned duties). If Yonder pouches are going to be used, I would expect that staff would also be required to not have a cell phone out the entire school day as to model this for students.
- Student safety and immediate communication with parents. This is a huge issue and vital issue for me. The ability to communicate and know my children are safe and we know the daily plans each day are a big deal for working parents who are scheduling pick up and drop offs. Open communication with my children during the day is a very important issue for our family,
- A lot of students use their phone to listen to music. It's an anxiety issue and helps them relax. Also, some students just carry their phones out of habit. Also, one time a student was accidentally locked in a bathroom, and had to use their cellphone to have stuff unlock the door.

There are a lot of situations that can happen. What if a shooting happens and we have to get ahold of our children.

- It's 2022. We should be able to communicate with our kids. I agree. Not out in classroom. But between classes and home room should be available.
- I don't believe you will follow any of our suggestions. You haven't on any other items. Your agenda is already set. You are just using this to say you asked people.
- Why do you have a cell phone? Communication with my kids
- The pouch is just another way for the district to waste money. This is 2022, don't treat the students like prisoners and they won't act like prisoners. Set guidelines such as work needs to be done, no making TikTok videos etc. Simply Enforce the rules!
- My only concern is if there is an emergency at the school and you need to know that your child is safe
- I do not believe Yonder pouches should be used in the case of an emergency happening. We have seen an increase over the years in school shootings and with as big as DHS one side of the building may not know what is going on on the other side and kids not having access to their phones could result in dire consequences.
- I think texting is a great way for students to stay in touch with parents. I see it as more beneficial in the upper grades, and have sent cell phones to school with my kids for this reason. I believe they can easily be allowed use during passing periods, and at lunch. I also understand that it could end up being "one more thing" for teachers, and I do not want to see an extra burden in that regard. I also understand that while my kids can generally just call and text because they do not have much data, it may be problematic for students who want their phones for surfing the web, or using apps, not for communication. I do remember that when I was in school (30 years ago) there was a payphone near the office. As a teenager, I remember appreciating this connection to home.
- I feel better knowing my child has their phone on them
- My child should have the right to have a phone at school in case of emergencies. They should not have the phone out and playing on it, but they should have the right to contact a parent if they feel unsafe, have an emergency etc. Or a parent can message them for transportation issues or emergencies. If it's not a parent they are messaging they should be in trouble for playing on it.
- The Yondr products are facing legal challenges in many locations since they directly block access to contact 911 and emergency services. That is a poorly executed product and should not be considered. The district has enough litigation and liability exposure without creating new opportunities for law suites. I have had personal experiences with picking my student up for a Dr appointment and the school failed each time to notify my child that I was there to pick her up. I also have had a number of times when my child is notified to stay after school for various programs. I'm not clear how else she would be able to notify me in a timely manner. In emergencies students should be able to contact parents.
- There is a office phone for a reason kids are at school to learn
- Adults work and have their phones available. Teachers sit in meetings on their cell phones, laptops, etc. As adults, we have a do as I say not as I do mindset. We expect kids to follow expect but we don't follow those same expectations when we are in settings when we should. I am that parent that text my children during the day whether it's about missing assignments,

pick up arrangements after school, or a family issue......I think it's a matter of teaching them appropriate and inappropriate times to have them out.

- I think the high school students should be able to use phones during lunch, homeroom, passing periods and study hall. I think they should be put away during class or face disciplinary action. I've heard that arranging fights with cell phones has been an issue. I don't think locking cell phones in pouches will cut down on arranging fights. High school kids have always arranged fights. They'll just find another way.. maybe back to passing notes. Considering the climate of school shootings, for my child's safely, I DO NOT support the pouches. I want my child to be able to contact someone if he doesn't feel safe. That should not be taken from him or any other student.
- hard life issues outside of school, students outside possible jobs.
- I am aware that phones can be a huge distraction. Unfortunately, the videos I've seen of the female resource officer being slammed into the wall by a male student is scary for me. The fact that water bottles have been throw in the direction of my child several times this year is also an issue. The safety &.mental health of my child hugely outweighs the inconveniences for the staff at the buildings. A good teacher will be able to hold the kids' attention and gain the respect of those students within their classrooms. I do believe that students age and maturity is definitely a factor. My 6th grader does not own a cell phone, because she isn't old enough. My 10th grader is plenty mature enough to know when to use her phone and when not to.
- Phones are integrated into our lives and will be for the foreseeable future in the lives of our children. Learning to be responsible with your phone has value. During instruction, phones should neither be seen or heard. While, phones should be on silent, vibrate or off; children are forgetful. Even adults are forgetful in this regard. Kids should just be reminded to silence their phones if they get an audible notification or call. We don't need special pouches. That teaches them nothing.
- It's a distraction School isn't meant for accessories you're there to learn not play
- I think it is important to have contact with my high school age child throughout the day to relay important information. For instance, if she needs to let us know that something significant has happened at school that day and she is safe or if I need her to pick her brother up or be home at a certain time to watch her brother due to an emergency. With the number of incidents of school emergencies I feel safer being able to contact my daughter during the day and knowing she can contact me if she needs to.
- As a teacher, I am fed up with cell phones. Students cannot stay off of them and are missing a lot of instruction. They're huge distractions. They're used too often for bullying or setting up meeting spots for skipping class (or worse). As a parent, I'd like to be able to contact my kiddo for some of the reasons I mentioned in a previous response, but overall...cell phones need to be locked away!!!
- I believe my child has the right to her cell phone, things happen at school and she has the right tell me something in private. If she violates the policy then I agree she should be held responsible.
- It's the parents responsibility to teach their children when and where it's appropriate to use their phones. It's the school's responsibility to ensure the children have a fun and safe environment to learn. Cell phones can help with that in many ways. Sometimes they can be a distraction, that's why parents and teachers both need to communicate clearly with the children

when It's okay and not ok to be on them and what the expectations are. Then if they continue to break the rules the teacher should have the right to take the phone away and return to the child's parent or guardian.

- Parents allow our children to carry cell phones in case of an emergency and to be able to keep contact if something happens between home and school

- These kids have problems and might not want to call us from the school phone I need to talk to my child though out the day no matter what
- Keep them put up during school hours
- I want my child to have the ability to contact me at any time. There are enough safety concerns in our school right now I want to be able to communicate as needed with my child. I also have children with anxiety's during things like storms that I would like them to be able to communicate with me during sever weather to provide reassurance.
- My child should be able to use her phone I brought it for her so I should be able to say when she cannot use it not the school not District 118, they have tried to gain to much control over my child already.
- I am a single mom nurse anesthetist that needs to communicate with my children during the day, lunch and between classes I feel this should be allowed

Phones are a daily use, I use them at my job my child uses hers in school, she needs to copy notes but the slide is going to fast take a photo, she needs to record the lecture. Someone is harassing her and your teachers don't believe her she can record it. There was just a fight video going around on social media, a girl recorded it and now we truly know what happened and not some story told by kids. I feel as. If my child is a lot safer with her phone. My I ask you guys why phones are such a distraction ?
- I do believe something like the yondr pouches would be a great deterrent for distractions in the classroom. Although, I do feel like kids should be able to access their phones in between classes only. If a situation arises where the student needs to be contacted immediately then the parents can contact office personnel.

- In an emergency, or the school goes on lock down, my child gets sick, he has asthma so if his inhaler runs out or needs a ride home instead of walking.

- I attended district 118 schools through to 11th grade. 12th grade I attended a school in another state who allowed us to have our phones during passing periods, lunch, and free periods, and it drastically cut down on cell phone usage during class time. It worked extremely well.

  means of contact is the child's cell phone to call the parent. I didnt give my child a cell phone for
  the school to lick it up so they can't use/get to in case of a true emergency and as far as I'm
  concerned you guys basically have it almost like a prison there for them kids now. I realize your
  trying to keep the kids on their schoolwork that I understand more than you will ever
  know.every time I hear my child is on his cell phone I have a talk with him about it but I don't
  think locking their cell phones up is NOT the answer
- It would be different if our children were attending a private school with private rights. There's also a difference between being on your phone in class and using your phone as a distraction. In the technology-based world we live in, students are more than capable of listening to their lectures and replying to a message.
- I understand that cell phone usage is a problem, but there are students who are not breaking the rules and try hard to follow the expectations. I would also offer that many teachers don't enforce the current cell phone expectations. The internal house must be in order before changing expectations again. Perhaps the yonder pouches should be used as a step in disciplinary action and not something that affects everyone.
- There is a phone in every classroom that a parent can contact the teacher and their child through.
- They can keep them in their pockets and only use them between classes or free time in class. Also, my kids can tell me if practices are cancelled that day to keep us updated.
- if you take the childrens phone and lock them then the teachers phone are to be treated the same. i do not agree with locking the phones in a pouch in case of emergency. the school also does not answer the phones like they should
- It should be allowed to have for emergency purposes and contact with parents. Should not be used for games or entertainment if caught doing so it should be put away when teacher requests. Refusals should be dealt with with disciplinary actions and contact with parents. I am more at ease with my child having hers and being able to contact me if she is having issues, bullying, and if she isn't feeling well. My child feels more relaxed knowing she can contact me when she needs to.
- When I was in school your phone had be put away, and sound off unless the teacher gave you permission to use it. It should stay that way.
- For my child's safety they should be allowed to have their cell phones. I'd rather her from my child and know they are ok than want for an automated call an hour later to tell me what

happened at school. There are many situations happening at schools that these kids should have their phones. I understand they need to be focused on school if you need to discipline ones that don't listen I understand but not all should suffer.

- So if using this what is the point of them having their phone. I feel there could be better consequences for just random usage of the phones. Any thing sent in emergency or transport change should be shown to a staff member to verify the need.

The school would have a massive problem if I found out that my child's ability to communicate with me was in any way hampered whatsoever.

I think the rules need to be clear and followed by all teachers and supported. Have to be willing to suspend, take phones, etc. its a tough one but i really would rather my children have them.
- I do not believe that students should be on phones during class, but there are way too many times that athletic practice schedules change at the last minute and we need to be able to get that communication from our daughter since the coaches do not communicate with parents. That along with our daughter being from a split home and sometimes needing to make changes in who is picking her up requires us to be able to communicate with her while she is at school. If we did not hear from her until after school there is no way we would be able to coordinate these daily events.
- If students are responsible & mature with their cell phones during school hours, they should be able to have it in their possession.

- I feel that there are times that use of phones can be appropriate, at least at the high school level. Younger students may need the more black and white approach. There are students who abuse the use of phones and there can be consequences of that---inappropriate websites, watching a streaming service instead of doing work. But then there can be legitimate times when students need to do something on their phone and should be allowed. If teachers and students can agree on reasonable expectations it would allow for better relationships between staff and students also.
- The yonder pouches only unlock when the children leave the school. How will it work if there is a problem at the school (shooting, fire, etc.)
- I think they are A HUGE distraction
- I feel that cellphones inhibit learning. They should be used only before or after school. Any needed communication should go through the school's office just like always has been. Cell phone usage during school inhibits learning and can be used to cheat rather than actually learning. No different to me than passing notes in school when we were kids.
- Surrounding schools don't allow phones during class. School is for students to learn and they won't learn anything if they have their phones and aren't paying attention.
- Corrective actions should only be taken if cell phone use is in the classroom. Do not make
  students hate going to school more than they do- when you've already added so many
  restrictions. Teachers signed up to have patience for kids, I understand how frustrating it can be

- As my daughter is my emergency contact, the school should be prepared to ensure that the student can immediately use a school phone/contacted immediately if needed. I believe that the school can handle this but in specific situations, the school should have a specific line to contact so that a message would not have to be left by emergency or hospital employees. For FYI, my student will not be attending due to graduating so this will not affect us, but there be others that might be in the same situation.
- Being on the phone in class for social media/ games ahhhh oils not be aloud, but using a calculator or any other tool/ talking to their parents is a right. The school doesn't pay for my child's phone
- you cannot keep children's phones from them they aren't your property and honestly it's not effecting the school you guys just make big deals about it

- I feel that they should be accessible to the student in case of an emergency or to possibly update a parent on something occurring or that may be occurring before having contact with the parent after school.
- With tragedies that have happened in schools I would like to be able to contact my child. Also with recent gun threats in Danville schools I find it reassuring to be able to contact them to check on their well being. Phones should have some limitations to them but they should be on their person and able to send or receive messages.
- Our youth have so much entertainment screen time as it stands. I understand that this is the current culture, but I think they would be more engaged in the learning process without the added distraction. This would also promote healthier habits by reducing reliance on engaging though a device .
- I believe children should be able to have their phones for use during personal time. I do not believe any usage during class should be tolerated.
- "This could be come a huge issues for those children whose cell phone is used as a medical device and sets the district up for lawsuits should harm come to one of these children.

- Honestly I have mixed feelings. Adults carry and use cell phones throughout the day, not just school staff, several other professionals too. College students carry phones and use them freely in class. While I understand it's a distraction in the classroom, and that some students are immature in what they use them for (recording fights, sending mean messages, coordinating inappropriate behavior and bathroom meetings), the fact remains that they are a part of day to day life for most people. If there were ever an emergency I want to be able to contact my child, not the school office, not an automated message. I know cell phones are a PITA, I work there, but I also know as a parent I want to be able to contact my child and have them contact me if they need to.
- Start punishing kids who don't follow the rules instead of punishment for kids who don't listen. Kids should be allowed to use their phones during lunch and if a teacher sees fit.

The allowed usage and consequences for violations should be well communicated to the student body and this must be consistent across all faculty members. Usage during passing periods should be allowed or during non instruction time provided it doesn't interfere with the

education process. Explain clearly and hold them accountable. Not all faculty are consistent in the policy and this leads to more problems.

- If they are banned they need banned for staff as well.
- Kids shouldn't just freely use their cell phone but it's necessary to have incase of a family emergency
- I would like my child to have access to me in case there was an emergency.
- what's the point have having the phone in the yonder pouch thing if they can't see any important messages from they guardians, don't play. gonna be unlocked before they get home-ya'll might as well keep them at that point.
- I want my child to have his phone available to him at all times. I do not want him on it during the day but I trust that he will do the right thing and use it only when appropriate. If this is not the case, I would want to know that as well so that it can be taken care of at home. This is a different world in which we live today and I cannot fathom not being able to get in touch with him immediately if necessary.
- i don't support it
- As long as students are finished with their assignments and have permission from their teachers, I don't have a problem with phones. Why is this now an issue?
- My child has her phone with her in case of emergencies only if I need to reach her or if she needs to reach me if you lock him in a case that can't happen
- I think phones should be allowed on silent in bags or something like that not to be used thru out the day maybe just to check on lunches or breaks only. In class use should not be allowed at all
- Too many terrible things can happen for my student not to have a phone.
- I would gladly like to discuss the legal ramifications of the district not allowing my daughter to not only have her phone on her at all times, but to also be allowed to use it discretely.
- I agree that cell phones can cause major disruption during class instruction and support the current rules with cell phone usage. From what I have been told, some teachers allow students to use their phone if their class work is complete as long as there is no sound. I have no problem with that as long as students use their phone in the right manner. It makes me feel better knowing my children could contact me during the day if there is a school issue or emergency. I also appreciate it if my oldest son is able to contact me during the day if there is a change of plans for his after school activities. My husband and I remind our son to not use his phone during instruction time and when he is completing his schoolwork and use it if the teacher is allowing it. My concern with the Yondr pouch is whether the phone will be unlocked in between classes so if there is a need to contact me, then they can do so in between classes. We would keep our texts to the minimum. In this day and age, parents appreciate being able to make sure their child is safe and can contact us if there is a need.
- If something comes up and we need to talk to our kids we should be able to
- Tell them to not have it out while in the middle of a lesson but during their time, that's their time and I think it's okay as long as they have a good grade in that class and get their work done.
- Students should be allowed to have their cell phones on them during the school day. They should be able to communicate as needed for important items such as emergencies, schedule changes, ride coordination, etc. Will some students abuse the privilege of being able to continue carrying their phone on them? Yes. Should all students be punished because of that? No. There are much bigger issues that should be getting more visibility and more attention, such as the

quality of education the students are receiving. More attention is paid to trivial matters and not to the actual education and quality of that education that the students should be getting.

- For years it said "no leggings" and every day 100s of girls walked in and out with them on... no comments, no redirection, nothing. so after 3 years my daughter said "mom the teachers and staff don't really care about the dress code rules they have why should I?"

- Enforce and uphold the rules you already have before wasting time making more. Students rise to the level of expectations you have for them. We have huge issues in this district...Culture change is hard. But it is possible.
- I don't like that phone would be locked. In case of an emergency is there a way to unlock them immediately ? If not, I am not in favor of this
- ""The use of cell phones by students during the school day causes major disruption to the school environment."" The major disruption to the learning environment are the number of fights that

occur on a weekly basis at both the high school and middle school. Phones are the least of anyone's concern! It takes one gun brought into the school that changes a community forever. Lets focus on that rather than a cell phone problem. Let's get our priorities straightened out. My wife and I had to buy a cell phone for our 8th grader this past semester because she felt unsafe in her school. We had a rule before moving to Danville that a cell phone was something you received once you got a driver's license. Unfortunately with the issues in both the high school and middle school, we had to purchase one early. I truly wish that the administration would understand what kind of learning environment this creates for the entire student body. As a parent of four children in the Danville school system, it looks like an abdication of responsibility on the administration.
